Admission Process for Master Business Administration (MBA) Program under Management Quota for the academic year 2021-2022

1. Eligibility for admission

- a. Admission to MBA program shall be open to the candidates who have passed the Bachelor Degree examination, with not less than 50% of marks in the aggregate of all years of the degree examinations. However, in the case of candidates belonging to Schedule Castes, Schedule Tribes and category-I the aggregate percentage of marks of the all the years of the qualifying examination shall be not less than 45%.
- b. Provided further that in respect of candidate who has studied and passed one of the subject specified in first provision in the Pre-University Course with 50% of marks in the subject shall also be considered for admission. However in the case of candidates belonging to SC/ST and category – I, 45% of marks in that subject shall be eligible for Admission.

2. Duration of the Program:

The MBA shall be of two years duration extended over four semesters.


